

OUT AND ABOUT PENINSULA TRANSPORTATION MEMBER AGREEMENT

Please read, sign and return to the Peninsula Shepherd Center Office

General:

- Riders must be mentally alert.
- The Out and About Transportation Program annual **membership fee is \$75**. The membership fee covers you for a full year and for all your transportation needs.
- PSC reserves the right to refuse service to any client deemed inappropriate for the program.
- **Cancellations:** If you need to cancel a ride, please notify the PSC office as soon as possible.
- **Driver Issues/Concerns:** If there is a problem or concern with a driver, riders should call PSC and notify the staff immediately, at 619-223-1640.

Van Shuttle Service:

The daily van shuttle service is available 6 days a week; Monday-Friday 9:00am – 1:00 pm and Sunday church services. The van shuttle takes clients on local errands, shopping centers, doctor's appointments, social outings and to church.

- **Members must call by noon the day prior to the requested ride date.**
- If you have an appointment time, please let the scheduler know. Otherwise, all other rides will be picked up in an order that best fits the driver's schedule. You will be returned to the same location at which you were picked up. If you are not at the pickup site on time, you will be responsible for finding your own ride home. *(City bus or taxi cab at your expense.)*
- **Donations/Fees:** A suggested donation of \$5 is greatly appreciated for van rides.

Volunteer Driver Service:

The personal volunteer driver program provides individual rides for non-emergency medical appointments and necessary errands based on volunteer driver availability. No additional fee is required and there is no tipping the driver. **Clients must call at least 7 days in advance to request this service.**

I authorize representatives to contact persons whom I have listed in case of emergency. I, the undersigned, understand and agree to follow the rules for participation in the van and volunteer escort programs. I and anyone entitled to act on my behalf, waive and release the Peninsula Shepherd Center, its Directors, Officers, Employees and Volunteers from any and all claims of liability of any kind arising from my participation in the transportation program. I hereby assume full responsibility for the risk of bodily injury, death, or property damage. I further agree that the foregoing Release and Waiver of Liability and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the law of the State of California, and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
